## SHIPPING INFORMATION

### EARLY SHIPMENTS

Las Vegas Convention Center will not accept delivery of exhibit material prior to the specified move-in date. Please plan your shipments to coincide with the established schedule.

**NOTE:** Every exhibitor will receive a target schedule showing the time their exhibit is scheduled to check into the Marshaling Yard to start the unloading process.

### SHIPPING INSTRUCTIONS

**Advance shipments must arrive between Friday, February 13, 2026 and Tuesday, March 10, 2026.**

Freeman will accept crated, boxed or skidded materials beginning **Friday, February 13, 2026** at the above address. Materials arriving after **Tuesday, March 10, 2026** will be received at the warehouse with an additional after deadline charge. Warehouse freight will be delivered prior to exhibitor set up. If warehouse freight has to be moved in on a weekend in order to be in the exhibitor's booth for move-in day, an overtime charge may apply. Warehouse receiving hours are 7:00 a.m. - 2:30 p.m., Monday-Friday. If required, provide your carrier with this **phone number: 888-508-5054**. Refer to [Freeman Services Guide](#) for rates.

### DIRECT SHIPMENTS

Exhibitors who wish to ship their exhibit materials directly to the Las Vegas Convention Center may do so, via their own vehicle, van line or common carrier, but must note that the direct to dock freight can be received beginning **Sunday, March 15, between the hours of 8:00 am and 5:00 pm**.

**Direct to dock shipments cannot arrive before Sunday, March 15, 2026 based on target date and time.**

Direct shipments will be unloaded at the Las Vegas Convention Center and delivered to your booth. After unpacking is complete, empty crates and cartons will be stored and then returned at the end of the show for repacking. Packed material will then be returned to the loading area and reloaded for outbound shipment.

**NOTICE:** The responsibility for in and out traffic scheduling has been assigned to Freeman Company, and they have complete jurisdiction over all loading areas. To assure order and expeditious handling of exhibit material before and after the show, exhibitors are asked to clear all freight movements through Freeman Company and to cooperate in the following established rules and observing the schedule.

### DAMAGE TO EXHIBITS

While being loaded, unloaded or moved to the various booths or common carriers by Freeman, they will be responsible as outlined in our Limits of Liabilities Statement enclosed in the [Freeman Services Guide](#). Freeman **WILL NOT** be responsible for damage to materials improperly packed, for concealed damage, for loss of theft of exhibitor's material after same have been delivered to the booth, or before materials have been picked up for loading out of booth. It is suggested, however, that shipments be fully insured by exhibitor. This may generally be accomplished by "riders" to existing policies-often at no extra cost!

### EMPTY CRATE RETURN

Freeman will begin returning empty containers as soon as the aisle carpeting is removed from the exhibit floor. The entire process will take approximately 5 hours.
